If anything other than green waste is found in the container the contents will be billed as garbage, \$140.80 per ton, plus a labor charge of \$85.35 per hour with a minimum of 1 hour.

OTHER INFORMATION

Absolutely NO HAZARDOUS WASTE!!! NO PRESSURE TREATED WOOD, painted wood, (or wood containing any glues of any kind including partical board, plywood, etc.) NO DIRT OR SOD, BAMBOO, PALM FRONDS OR FLAX (water leaf). NO FOOD WASTE OR CARDBOARD.

Any hazardous waste found in the container will be removed for you to pickup. In the event we are unable to reach you in a timely manner, we will deal with the material. You will be billed for any additional labor costs incurred at Humboldt Waste Management due to additional handling and disposal of the material.

If we are unable to deliver the bin due to circumstances beyond our control (such as road conditions, landscape, brush and/or low tree branches, power lines, etc.) you will be subject to a **Labor charge (\$85.35 per hour, minimum of 1 hour) & Mileage charge of \$3.00 per mile round trip from the shop to destination.** This charge will also apply if there has not been previous arrangements made to keep the bin beyond the 3-day rental period. It is the responsibility of the renter to call before 8:00 am of the arranged pickup day if you wish to extend the rental period and avoid additional Labor & Mileage charges.

IMPORTANT

Customer is responsible for the container / drop box for fire, theft, graffiti or other damage and insurance. Material in the load must be evenly distributed and not overloaded. Load must not exceed the top of the box or overhang the width of the box.
